# REGULATION C/REG.13/6/17 ON THE ESTABLISHMENT OF A REGIONAL QUALITY ASSOCIATION DESGINATED AS ECOWAS QUALITY AGENCY (ECOWAQ)

#### THE COUNCIL OF MINISTERS,

MINDFUL of Articles 10, 11, 12 and 26.3 (L) of the Revised ECOWAS Treaty, as amended, establishing the Council of Ministers and specifying its composition and functions.

**MINDFUL** of Article 26(3I) of the Revised ECOWAS Treaty on the adoption of common standards and appropriate quality systems by Member States;

**MINDFUL** of the Additional Act A/SA.1/02/13 adopting the ECOWAS Quality Policy (ECOQUAL) and its implementation Framework;

**MINDFUL** of the Additional Act A/SA.2/07/10 adopting the Common Industrial Policy of West Africa (CIPWA) and its action plan,

**MINDFUL** of Regulation C/REG.14/12/12 adopting the ECOWAS Standards Harmonization Procedures (ECOSHAM);

**MINDFUL** of C/REG.19/12/13 adopting the ECOWAS Regional Quality Infrastructure Scheme;

**MINDFUL** of Article 7 paragraph 4 of the said Regulation C/REG.19/12/13 adopting the ECOWAS Regional Quality Infrastructure Scheme which enables the ECOWAS Commission to establish regional quality structures;

**CONSIDERING** that the management of the ECOWAS Quality Infrastructure requires the creation of a coordinating body for all activities related to the implementation of this infrastructure;

**CONSCIOUS** that it is not sustainable to entrust the coordination of quality promotion activities to a Directorate of the Commission while ignoring the contribution and participation of the stakeholders;

**CONSCIOUS** also that only a community organization can enable the ECOWAS Commission and the Member States to ensure the effective implementation of policies defined in the context of quality promotion;

**DESIROUS** of establishing an agency for implementation of Regional Quality Infrastructure Scheme;

#### **ENACTS**

#### **ARTICLE 1: AUTHORIZATION TO SET UP**

The Council of Ministers authorizes the establishment of the Regional Quality Association, known as the ECOWAS Quality Agency (ECOWAQ), in accordance with Article 7 of Regulation C/REG/19/12/13 adopting the Regional Quality Infrastructure Scheme of ECOWAS.

#### **ARTICLE 2: IMPLEMENTATION MECHANISM**

The ECOWAS Quality Agency (ECOWAQ) shall operate in the framework of an act approved by its Constitutive General Assembly. This Act consolidates all the provisions necessary for its organization, operation and financing.

# ARTICLE 3: MODALITIES OF COOPERATION BETWEEN THE ECOWAS COMMISSION AND THE ECOWAS QUALITY AGENCY (ECOWAQ)

Pursuant to paragraph 4 (12) of the ECOWAS Quality Policy document (ECOQUAL) adopted by Supplementary Act A/SA.1/02/13, the Quality Agency (ECOWAQ) will be entrusted, through a Memorandum of Understanding, with the operational management of the Quality Infrastructure Scheme of ECOWAS, including the implementation of the following missions:

- a) The assistance in implementing the decisions taken by the Community Quality Council;
- b) The management of a common Permanent Secretariat of the Community Quality Council, the Community Technical Committees and the Regional Accreditation System;
- c) The Management of the regional certification scheme and regional certification marks;

- d) The Supporting for the implementation of quality promotion activities, including the technical organization of the ECOWAS Quality Award and the management of Trademarks;
- e) All other activities related to the promotion of regional quality infrastructure

#### **ARTICLE 4: ENTRY INTO FORCE AND PUBLICATION**

This Regulation shall enter into force on the date of signature and shall be published by the Commission in the Official Journal of the Community within thirty (30) days. It shall also be published by each Member State in its Official Journal thirty (30) days after notification by the Commission
